3. Discuss draft budget for fiscal year ending May 31, 2020 and take any necessary action;
4. Hear tax assessor/collector's report, review report on delinquent accounts, consider any requests for installment payment agreements, and approve checks on tax account;
5. Hear operator's report, hear customer appeals and take any necessary action;
6. Consider amending Rate Order and take any necessary action;
7. Review Identity Theft Prevention Program, consider approving Order Reviewing and Confirming Identity Theft Prevention Program and take any necessary action;
8. Review Emergency Preparedness Plan, authorize Operator to update Critical Load Information with the appropriate entities and take any necessary action;
9. Review, confirm or revise Drought Contingency Plan and/or Water Conservation Plan, as appropriate;
10. Hear update on proposed development within the District and take any necessary action;
11. Hear engineer's report, consider authorization to advertise bids, consider award of any contracts, consider approval of any change orders, consider approval of any requests for availability of water and sewer service, consider repairs and maintenance as appropriate, consider acquisition of easements; and review strategic plan as appropriate;
12. Discuss and consider request regarding trash service within the District and take any necessary action;

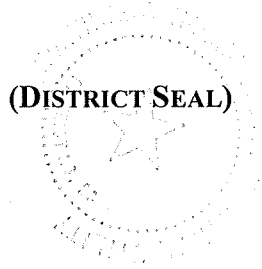
13. Discuss surface water issues; consider water conservation and drought contingency matters; and
